2022-2024 Line 3 IAMC Strategic Work Plan Summary

This Work Plan was developed by the Committee, and its sub-committees, to set out priorities, strategic goals, and core activities, along with a corresponding budget, to guide its work through the **two-year period 2022-2024**. This is a living document that is intended to be amended as needed and to reflect feedback received through ongoing engagement with representatives of Line 3 impacted Métis Nation and First Nations.

Vision

Meaningful Indigenous participation in Line 3 Replacement Program lifecycle activities and related policies, through an enhanced relationship among Métis Nation, First Nations, the proponent, Government of Canada, and the Canada Energy Regulator that supports informed decision making by Canada and the regulator.

Guiding Principles

- Ensure Indigenous Nations are meaningfully engaged and participate in government, regulator and proponent
 decision making processes regarding Line 3 Program activities so that these processes better reflect
 Indigenous peoples' rights, address impacts to those rights and interests, and honour the obligations of the
 Crown as set out within Canada's Constitution.
- Information is shared in a timely, cooperative, and transparent manner between Indigenous Nations, Government of Canada, Canada Energy Regulator, and the proponent (Enbridge).
- Respect for Indigenous obligation to natural law that protect the land, air, water, species, cultural values and laws, history of all Nations, and natural resources within the Line 3 corridor.
- Recognition for Indigenous peoples as part of the eco-system.
- Indigenous traditional and contemporary knowledge and obligation to the land is meaningfully reflected, and respected and implemented in the work of the Committee.

Priorities

Priority 1: Renewal



A renewed mandate for the Line 3 IAMC that is developed in partnership with Indigenous Nations, the Canada Energy Regulator, and the federal government, building on the foundation of meaningful Indigenous participation in Line 3 Replacement Program activities.

- 1.1 Shared understanding of the foundation built by the Line 3 IAMC, the lessons learned and the opportunities for the future.
- 1.2 Vision for the Line 3 IAMC and Indigenous Monitoring in the longer term.

Priority 2: Communications & Engagement



Ensure Indigenous Nations including leadership, elders, and youth: Are informed about and guide the work of the Committee and Have opportunities to engage with each other and with industry and government as appropriate, in working to protect Indigenous interests.

- 2.1 Consistent information to promote a greater understanding among Indigenous Peoples and Nations about the Line 3 Replacement Program and the work of the IAMC.
- 2.2 Include Indigenous knowledge, interests, and culture in the work and outcomes of the IAMC.

Priority 3: Indigenous Monitoring



Indigenous peoples are involved in the monitoring of environmental, safety, and culturally sensitive aspects related to Line 3 activities over its lifecycle, with meaningful and adequate consideration of traditional land use, sacred sites, historical knowledge, and the diversity of Indigenous traditional and cultural worldviews.

- 3.1 A strong IAMC Indigenous Monitoring "IM" Program that supports IMs working with CER to monitor the environmental, safety, and cultural impacts within the Line 3 right of way and enable cultural exchange between Indigenous Monitors and CER staff.
- 3.2 IAMC guiding Enbridge, in their work on Line 3
- 3.3 Indigenous interests and perspectives are integrated with regulatory oversight of filed documentation on the L3RP

Priority 4: Emergency Management



Support meaningful involvement of Indigenous peoples during emergency preparedness and response; and support greater protection of Indigenous interests during emergencies.

- 4.1 Committee Members and Nations have an understanding of and participate in Emergency Management activities relating to Line 3; and Indigenous perspectives are reflected in Emergency Management processes and response efforts.
- 4.2 Emergency Management capacity enhanced in Nations with improved access to existing Emergency Management programs and with integration of Line 3 emergencies with all-hazards Emergency Management
- 4.3 Strengthened Emergency Management partnerships amongst Indigenous Monitors, Nations, the regulator, government, and other partners involved with Emergency Management activities.

Priority 5: Training and Capacity Development



Support information sharing, training resources, and opportunities that increase capacity for participation in regulatory oversight.

- 5.1 Indigenous Nations have capacity and supported to participate in regulatory oversight.
- 5.2 Indigenous Nations have awareness of and equal access to opportunities relating to the L3RP.
- 5.3 Committee Members are learning with each other and have opportunity to build relationships through capacity development with CER and Enbridge.
- 5.4 Indigenous culture is respected and reflected in the Line 3 Replacement Program.
